RULES FOR THE 10TH INTERNATIONAL COMPETITION OF YOUNG MALE AND FEMALE DESIGNERS "TENERIFE MODA 2018"

FIRST – OBJECTIVE

The present rules intend to establish the regulations of the 10th "Tenerife Moda" competition for young male and female designers. This competition hopes to encourage aspects of new meaning in fashion design.

SECOND - THE BENEFICIARIES

- 3.1 Those who may participate in the competition are individuals in a private capacity or groups under a common brand independent of their nationality or country of residence and who are 18 years old and no older than 35 on the 31st Dec 2017.
- 3.1 The beneficiaries must not have won any of the anterior editions of the competition and will not win if they do not obey the rule of the article 13 of the Law of Subsidies or Grants.

THIRD – NOTICE OF A MEETING

Conforming to the established article 23 of the law 38/2003 of the 17th Nov, General Subventions, the meeting will begin once approved by the President of the Insular Company of Craftmanship, S.A., strictly ruled by the following concepts:

Publicity, transparency, attendance, objectivity, equality and nondiscrimination.

Efficiency in the compliance of the principle

Efficiency in the assignment and distribution of the resources.

The notice of the meeting will be published in the List of Announcements of the Tenerife Cabildo (www.tenerife.es) web page of the EIASA, in the National Base of Subventions and in the Official Bulletin of S/C Tenerife.

FOURTH – WORK REQUIREMENTS

Each candidate will present under a pseudonym a collection of 12 models. You will be free to choose your own subject of inspiration

The participants will present their sketches drawn from the front and the back in format DIN A/4. They are obliged to write on the back the title of the collection, the design if there is one and the pseudonym of the person or persons competing.

The sheets of paper must be accompanied by a technical description of the model and optionally samples of material used in the making. The technical record, which should adjust as a minimum size 38 for women and 42 for men according to European size, must contain at least the following points:

Sketches with all the characteristics of the models.

Colour flags which identify the colour used.

Proposal of the style and materials.

Measurements to scale.

Record of costing.

Likewise you can add to the technical record any other document that you consider relevant to the costing of the project.

Any added description of the material sent should be presented in English or Spanish

The collection should be adequately defined, complete and show a sufficient description to be evaluated with the data provided in the technical description and the sketches.

The designs presented by those who participate in the competition must be original and inedited and never have been presented in any other anterior competition.

All these documents have to be handed in in digital format

FIFTH – SOLICITUDES AND DOCUMENTATION

The presentation of the solicitude of participation in the competition must implicitly obey and accept all and every one of the present rules.

To be able to guarantee the confidentiality of the identity of the participants they must present the following documentation:

- Application form (Anex.1) elaborated by the Insular Company of Craftmanship S.S., which will only collect a pseudonym that permits the identification of each participant.
- 2 envelopes which must contain the following documentation:

ENVELOPE A: On the outside you must indicate "Envelope A and pseudonym"

- Any identifying documentation such as identity card, passport etc
- Curriculum Vitae of the person who is to participate in the competition
- Fax or e-mail number used to communicate with the competition for the Insular Competition of Craftmanship S.A., which will be used for all notifications.
- A sworn statement that the collection presented is original and has never been awarded a prize or presented in any other competition.
- A sworn statement of not being liable in the exclusions of article 13 of the General Law 38/2003 of Subventions.

ENVELOPE B: On the outside you must indicate" Envelope B and pseudonym"

- It has to contain the sketches and the technical record with the title of the collection and pseudonym. With the provided data in the technical description and the sketches, the collection should be completely and adequately defined and contain a description which is sufficient to be evaluated in compliance with the criteria of evaluation established in Base 8

To falsify the fulfilled data in the sworn statements could mean rejection and the returning of the prizes if presented

The information obtained during all the process is considered exclusive property of the applicants and will be treated as confidential.

<u>SIXTH – PLACE AND TIME LIMIT</u>

The time limit to present the competition work will be specified in the corresponding Meeting. Once sent to the National Base of Data of Subventions, it will proceed by the same to require the publication of the corresponding extract of the official bulletin of the Province.

On the other hand, the time limit will finalize on the 12th Jan 2018. The work will be presented at the Insular Company of Craftmanship S.A. in Calle Tomás Zerolo 27, La Orotava 38300 Tenerife Spain

SEVENTH – MANNER OF NOTIFICATION

The communication with the interested parties will be through fax or email which the person should have given in fifth Base.

<u>EIGHTH – PROCEDURE FOR CONCESSION OF PRIZES</u>

The procedure of the concession of the prizes will be competitive, proceeding through comparison of the collections presented to establish a preference of the same in accordance with the criteria of evaluation established on 10th Base, conceding the prizes to those who have obtained the highest evaluation in the application of the aforementioned criteria.

Once defined the relation of the winning collections, it will proceed to the opening of Envelope A to verify that the participants have complied with the established requirements of the 2nd Base.

<u>NINTH - INSTRUCTION FOR PROCEDURE</u>

A jury will be comprised of:

- President: The vice-president of the Board_of Administration of the Insular Company of Craftmanship S.A. or delegated employees of the Insular Company in charge.
- Voters:
 A minimum of 5 and maximum of 15 representatives of the different Institutions, Organisms and Associations of public or private character within the world of fashion, design and culture.
- Secretary: An employee of the Insular Company of Craftmanship S.A.

In accordance with the jury who will judge this competition, it must be expressed:

- Relation of collections and designers who participate in the competition.
- Determination of the winning collections distinguishing between 1st,
 2nd prize with a succinct motivation of the reasons for such a distinction specification of the corresponding promoters.
- The manner in which the prizes will be conceded.
- Declaration in whatever the case of the prize or prizes which remain vacant and the use of the corresponding endowment to concede Accesit to collections which are considered deserving of such a distinction.
- Any other obligation which is esteemed convenient in order to guarantee the carrying out of the organized activity.

The referred Accord will be notified to a maximum of 6 candidates with the best punctuation and the results will be made known in a fashion parade to put on view the proposals of these.

TENTH – CRITERIA OF THE EVALUATION

For the concession of these prizes, as long as the candidate complies with the requirements demanded and is not included in any other of the exclusion causes expressly foreseen in these bases, the following criteria of evaluation must be considered in descending order.

- 1 Originality, quality and creativity in the designs presented
- 2 Innovation and adaptability to the market
- 3 Viability as a commercial procedure.

Each of these criteria, will be applied to each collection granting between 0 to 10 points, according to the criteria of the members of the Jury later calculating the average mark.

The application of the criteria of the evaluation in the earlier list will give place to an ordered list of the collections that comply with the established requirements in the present bases from more to less punctuation that will serve the concession of the foreseen prizes.

The prizes could be considered vacant and they could share and equal place (ex aequo).

ELEVENTH – PRIZE MONEY

The jury considering the before mentioned criteria will select a maximum of 6 finalists as well as 2 in reserve and later a fashion parade will be organized which will take place on the Island of Tenerife during the months March/April of 2018 where the prize winners will be declared.

After the selection of the candidates for the prize, each one of them must send in an article of made up clothing of the presented collection in competition, in the space of time that is shown in the notification of its pre-selection.

Once received, if this does not correspond with those included in the collection or with the quality of the finished "look" and/or the materials are considered insufficient, the candidate will be excluded and his competition collection and his participation in the fashion parades of the winning collections. After this exclusion he could be selected as one of the reserve candidates in order of punctuation as long as he brings together the quality requirements and to form part of the collection in competition before indicated.

The following prizes will be conceded:

- A- First prize endowed with 3.000 € (gross amount)
- B- Second prize, endowed with 2.000 € (gross amount)
- C- Special prize to the collection which obtains the highest punctuation on the commercial side endowed with 2.000 € (gross amount). In the case of this maximum punctuation having already been given to one of the prize winners, it will be declared vacant.

The promoters of each winning collection will receive a Diploma or accredited trophy.

Any of the prizes can be declared vacant making it possible that in the resolution of the competition any money that is used to concede Accesit to collections that are considered deserving of such distinction. The amount of the Accesit that can be conceded must not exceed 2.000€ (gross amount).

Apart from these, other institutions and companies can contribute funds to complement the prizes. They can also establish prizes that, sponsored by institutions or collaborating companies, can underline a special contribution and for this, pacts with other institutions can be established.

The ready-made form should adjust to what the sheet specifies and the indicated materials always being aware that the said model must adjust as minimum to size 38 in women and size 42 in men.

TWELFTH – ASSISTANCES

The 6 authors of the selected collections in the final in Tenerife will receive before the fashion parade, a maximum of 1.000€ destined to take care of expenses derived from the confection of the 10 models of their collection (materials and implements) incurred before the presentation or sending of the corresponding invoices. These invoices must contain at least the following data:

- Name and surname or reason or complete social denomination of the expedient.
- Name and surname or reason or complete social denomination of the recipient or client.

- Fiscal identification number of both the sender and the recipient or client.
- Complete address not only of the sender but also the recipient or client.
- Description of the operations together with the amount (net as well as tax)
- Number of the invoice and date of issue
- In case the invoice is sent in a language different from Spanish, it must be translated.

The invoices which do not contain each and every one of the above data will not be included as a subventionable expense.

The 6 finalists may obtain assistance of behalf of the EIASA to confront travelling (including transporting the collection) and lodging in Tenerife to be present at the prize giving and the fashion parade of the collections presented in the competition. The amount of said assistance will not exceed 2.500,00 €.

<u>THIRTEENTH – OBLIGATIONS OF THE BENEFICIARIES</u>

With the presentation of the application, it will be presumed that there will be an inconditional acceptance of the present bases, conditions, requirements and obligations that is contained in the same. Each and every one of the prizes granted in virtue of the present bases will be conditioned to be fulfilled on behalf of the beneficiaries of the obligations which are imposed. The nonfulfillment of such obligations by the beneficiary will mean that the provisional granting of the prize that would have corresponded to them would be ineffectual.

The prize winning works must be ready for the fittings on the day that the organization will communicate, being the responsibility of the designer any adjustments change or anything that is decided on behalf of the style team of the organization.

The works already preselected must be presented with the corresponding style, shoes, accessories which complement the collection which can be changed by the style team of the competition.

The works which have no prizes nor are selected can be collected or reclaimed but must be solicited by their owners before the 31st March 2018. In the case of non-reclamation within the time, the collection will be destroyed

The organization will not be responsible for damage that the materials may suffer as a consequence of transport, manipulation, exposition, storage of similar.

The prize winning designs will remain as "historic" in possession of the Insular Company of Craftmanship S.A. maintaining the intellectual property of the owners of the presented creations. The participants will lose the right of exhibiting their designs and their use in the making of posters, diptychs, press, television etc., on behalf of the Insular Company of Craftmanship S.A.
